

Artscape Arts and Crafts Festival Lakeside Park, Pell City, Alabama

ARTSCAPE is a festival sponsored by the Council of the Arts, Inc. serving St. Clair County, Alabama. This family event features local fine art and traditional crafts

ARTSCAPE is a rain or shine event. The festival will not close during intermittent rain. In the event of prolonged, inclement weather, the festival may be canceled with no refunds given.

Awards

ARTSCAPE is a juried show. The selection of artist participants is based on creativity, quality, originality, and booth presentation. Awards will be presented to selected works for 1st, 2nd, and 3rd Place. One Best of Show award will be presented. Awards are given at the discretion of the judge. The judge's decision is final.

Jury Photos and Fee

Applicants must furnish three digital photographs of their work and one picture of their booth set-up. No slides please. PHOTOGRAPHS WILL NOT BE RETURNED. All work exhibited must be comparable to the work shown in the photographs provided. Applicants must include a \$10.00 non-refundable jury fee with their application. Applicants selected for participation in the festival will receive a final acceptance letter with set-up and lodging information. Once accepted, no refunds will be given. Checks or money orders from applicants not accepted will be returned.

Vendor Guidelines and Booth Fee

- ◆ Booth fee is \$35 per 12' x 12' booth space.
- ◆ All merchandise presented for sale by festival participants must be hand-made. No exceptions. No manufactured or mass produced items are allowed. Artists may sell copies of their own works of art. Example: greeting cards or printed clothing and prints made from the artist's original artwork.
- ◆ Sales tax must be collected by each vendor in the amount of 9% payable to the state and the city of Pell City.
- ◆ Vendors must be present during the entire festival to display and sell their arts/crafts.
- ◆ The Council of the Arts, Inc. reserves the right to remove any artwork inappropriate for a family event.
- ◆ The Council of the Arts, Inc. reserves the right to reject any application for entry into the festival. They also reserve the right to terminate the participation of any festival participant at any time. Participants terminated shall not receive any refund and will not be allowed to participate in future festivals.
